The Grand Island Public Schools Foundation creates expanded opportunities and access for the students of the Grand Island Public Schools through philanthropic investment. Their robust scholarship program this year offered \$514,508 in college scholarships to both high school students seeking dual credit and graduating seniors. Other individual grants include kindness grants to fulfill a student need when it is identified. These include paying off lunch accounts, acquiring tennis shoes or a coat, paying registration for choir clinics, etc. Additionally, the Foundation invests in groups of students and their teachers through classroom grants, special projects, capital purchases, teacher training/scholarships, and the Teacher of the Year Awards.

The Grand Island Public Schools Foundation acts as the philanthropic arm of the Grand Island Public Schools. For the past 4 years the Foundation has been actively raising funds for the building and renovation of Grand Island's Memorial Stadium. The project is a \$17 million project. Construction of the project has been completed during fiscal year ending August 31, 2021.
