The Grand Island Public Schools Foundation creates expanded opportunities and access for the students of the Grand Island Public Schools through philanthropic investment. Their robust scholarship program this year offered \$502,668 in college scholarships to both high school students seeking dual credit and graduating seniors. Other individual grants include kindness grants to fulfill a student need when it is identified. These include paying off lunch accounts, acquiring tennis shoes or a coat, paying registration for choir clinics, etc. Additionally, the Foundation invests in groups of students and their teachers through classroom grants, special projects, capital purchases, teacher training/scholarships, and the Teacher of the Year Awards.

At the beginning of every board meeting, they discuss the agenda to see if anyone has a conflict of interest. If an interested person exists, they may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict. The chairperson of the governing board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement. After exercising due diligence, the governing board or committee shall determine whether the Organization can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of

interest, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Organization's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement. If the governing board or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose. If, after hearing the member's response and after making further investigation as warranted by the circumstances, the governing board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

The Grand Island Public Schools Foundation Board shall utilize either its Human Resources Committee or Executive Committee to annually evaluate the Executive Director on his/her performance, and ask for his/her input on matters of performance and compensation.
